
As per the Gazette Notification No. 22021/1/2008-CRC-II, DT. 30.12.2011 issued by Government of India to switch over from UHV based gradation system to GCV based system and in pursuance of the Colliery Control Order 2000, issued by the Govt. of India on 1st January 2000, in partial modification to our earlier Price Notification No.143/2025-26, dt.01.11.2025, covering coal prices for GVCF, Telangana mines and Naini coal mine, Odisha, it is hereby notified that the basic prices, other charges, taxes and levies in this Notification shall apply exclusively to the sale of coal from Naini Coal Mine, Odisha state.

This Notification is being issued as a stand-alone and independent Price Notification for Naini coal mine and shall supersede all earlier Price Notifications to the extent they relate to sale of coal from Naini coal mine as contained in any previous combined Price Notifications. This Notification shall come into force w.e.f. “00.00” hours of 20.01.2026.

1. The following are the Grade-wise GCV based Basic prices of Run of Mine (ROM) coal excluding statutory levies and other charges applicable for Sale of Coal from the Naini Coal Mine, Odisha state of the Singareni Collieries Company Limited:

2. Basic price of Lower Grade Coal = Rs.400/T
3. Basic prices of crushed ROM coal for Power & Non- Power sector customers are furnished as Annexure-1.
4. **Notes:**
 - i. Run of Mine coal is coal comprising of all sizes which comes out of the mine without any crushing or screening.
 - ii. The fraction of the Run of Mine coal as is retained on a screen when subjected to screening OR is picked out by fork shovel during loading is called Steam/ Round coal.
 - iii. The fraction that remains after Steam Coal has been removed from the Run of Mine coal is called Slack coal.
 - iv. When the top size is limited to any maximum limit within the range of 200 – 250 mm through manual facilities or mechanical facilities is called Crushed ROM Coal.
5. Where the top size is being limited to any maximum limit within 250 mm through manual facilities or mechanical means, an additional charge of Rs.87/- per tonne will be levied for the coal loaded from Naini coal mine.
6. The Pit-head / Coal Handling Plants / Coal Screening Plant prices fixed are exclusive of Royalty, cess, taxes and levies, if any, levied by the Govt., Local authorities or other Bodies.
7. For undertaking special sizing or beneficiation of coal, additional charges as may be negotiated between the Purchaser and SCCL will be realized over and above the notified prices.
8. An additional charge of Rs. 60/- per tonne towards evacuation facility charges/ loading charges shall be levied for the coal loaded from Naini coal mine.
9. Additional Charges of Rs. 20/- per tonne will be levied towards “ Corpus of CMPS 1998 (Pension fund)” for all grades of coal excluding Washery Rejects, Washery Slurry and Washery Fines.
10. Royalty is charged @ 14% ad-valorem on price of coal including ungraded/Low Grade coal, as reflected in the invoice, excluding taxes, levies and others charges as per Gazette Notification No. G.S.R.349 (E) dt. 10.05.2012.
11. As per the Gazette Notification dt. 21.08.2025 & 01.09.2025 regarding “Mines and Minerals (Development and Regulation) Amendment Act, 2025, No. 28 of 2025, an additional 3% on Royalty is levied w.e.f. ‘00-00’ hours of 01.09.2025 towards National Mineral Exploration and Development Trust (NMEDT) Fund.
12. As per the Mines and Minerals (Contribution to District Mineral Foundation) Rules, 2015, ten percent (10%) of Royalty is levied towards the District Mineral Foundation Trust (DMFT) for the coal supplied from Naini coal Mine, Odisha.

13. Additional prices applicable to the concerned dispatch points & grades and other charges like Surface Transport Charges, Additional Transport cost, Evacuation / Loading charges etc., and Statutory duties and taxes like Royalty, Royalty on Premium, Additional Royalty, DMFT, NMEDT, Reserve Price and Corpus of CMPS 1998 (Pension fund) etc. are chargeable over and above the notified price. In addition to the above, CGST of 9 % and SGST of 9 % on sale of coal within State and IGST of 18 % on sale of coal outside State are chargeable over and above the taxable value.
14. An additional amount (Additional Royalty) equivalent to the Royalty payable is charged for all the grades of coal as per the Section (8) of MMDR Act, 2021 for all grades of coal.
15. As per the directives of Ministry of Coal, Government of India, vide File No: NA-202/1/2016-NA, Dt: 15.10.2025, Reserve price of Rs. 126.24/- per tonne of coal shall be charged on all grades of coal.
16. User Fee of ₹1/tonne is levied for coal sold/supplied from Naini Coal Mine w.e.f 01.11.2025 as per the Government of Odisha vide Gazette Notification Ext. No. 2032 dated 19.10.2012.
