4. **Tenderers are requested to submit hard copies of the tender documents (including original EMD) in the Office of Addl.Manager (Forestry), The S.C.Co.Ltd., Corporate within 3 days from the date of closing of the tender and those who do not submit the tender documents (including EMD), within three (3) days from the date of closing of the tender, will be treated as invalid tender and will be out rightly rejected and also debarred from participating in the future tenders.**
5. The **Price Bid (Part-II)** of the bidders who are qualified in the Technical Evaluation only will be considered acceptable and will be opened on approval of competent authority on **06.03.2017 at 4.00 PM**.
6. Earnest Money Deposit can be paid in the form of Demand Draft (DD)/ Fixed Deposit receipt (FDR) duly endorsed in favour of SCCL , if the EMD is to be paid in the form of DD, it should be payable at Kothagudem from any Nationalized Bank.
