2. a). The tenderers are allowed to download the documents from the date of publishing the tender notice to 12.30 pm on **20.02.2017**
b). The tenderers are allowed to submit the bids upto 3pm on **20.02.2017**.
c). The tenderers who have filed the tenders need to submit the documents with in three days from the date of filling the tenders i.e., upto 3 pm on **23.02.2017** otherwise their tenders will not be considered.
d). Technical bids will be opened on **23.02.2017** at 5 pm.
e). The tenderers who have submitted their documents and who have qualified in the technical bid only will be considered for price bid opening.
f). The price bids will be opened on **27.02.2017** at 3 pm.
g) Negotiations will be conducted to the L1 agency after tender opening in the Office of SO to General Manager, Mandamarri area is intimated.

3. Earnest Money deposit can be paid in the form of Demand Draft (DD) / Fixed Deposit receipt (FDR) duly endorsed in favour of SCCL, if the EMD is to be paid in the form of DD, it should be payable at Mandamarri from any Nationalized Bank.
4. FDRs/DDs etc., so submitted should be valid for the entire period of the contract from the date of opening of the tender.
5. Request for adjustment of pending bills of the Company towards Earnest Money Deposit (or) resubmission of once discharged FDR taken on other works will not be entertained.
6. The earnest Money Deposit will be refunded to the unsuccessful tenderer immediately after finalizing the L1 tenderer.
7. The Company reserves the right to cancel/withdraw whole or part o the above mentioned works without assigning any reason what so ever.
8. The Company employees should not participate in tenders either directly or indirectly.
